### GENERAL RULES AND CONDITIONS (L.A.)

#### ELIGIBILITY

1. **EDUCATIONAL QUALIFICATION**: The candidate should have cleared 10+2 or T.D.C. First year (in old

scheme) with subjects Physics, Chemistry and Biology from Higher Secondary Board, Ajmer or equivalent, Candidates from Agricultural Sciences field can also apply.

2. <u>AGE</u>: Minimum eligible age 17 years. (Relaxation in maximum-age as per State Government rules and instructions)

#### SCHEME OF ADMISSION

A list on basis of merit would be prepared, in accordance with the rules and regulations as laid by the Government, from the submitted application forms. The last date of submission of application from and the date of issue of list/s should be in qured from the Admission Office. These selected candidates would be called for an interview and on basis of performance in interview and academics, admission would be granted. Call fro interview does not guarantee admission. All relevant certificates and documents should be presented at the time of interview. The applicant will have to check for himself the list/s from the Office. On letter or call to the applicant will be made unless otherwise specifically mentioned. TA, DA, etc. will not ve paid fro the interview.

#### RESERVATION

Reservation as per Government policies will be provided.

#### COURSE

Course duration and contents will be according to the policies of State Government.

Fees are to be deposited within a period 7 days (including working and non-working days) from the date of admission, failing which the Admission Office reserves the right to cancel the admission and grant the seat to next deserving candidate. The fees for the first year are to be deposited at the time of admission. In addition to this a Bank Guarantee is to be furnished by the candidate disclosing his/her ability to pay the fees (this includes all fees and expenses, taking into account inflation, economic conditions etc., as demanded by the course coordinator) for the next two years. Fees for each year are to be paid before the next session starts to avoid any in-disciplinary action. No amount or deposit will be refunded after the admission. Enrolment/Registration fees as demanded by the State Government will also have to be paid by the candidates in addition of other fees.

#### DISCIPLINE

1. <u>ATTENDANCE</u>: A student must have 80% attendance in lecture and practical (individually.) In addition to this 90% clinical should be attended on an annual basis.
